



## TERMS OF USE

These Terms of Use bind you as a user of e-SPACE Aging Well, personally or on behalf of an entity owned by you ("you", "your"), to the researchers who participated in the development of the content of the e-SPACE Aging Well platform ("e-SPACE") and their institutions, including the CIUSSS du Centre-Sud-de-l'Île-de-Montréal ("we", "our"), and legally regulate your use of e-SPACE, as well as any other type of media, website or mobile application related to its functionality. You acknowledge that by using e-SPACE, you have read, understand and agree to be contractually bound by these Terms of Use and that you agree to comply with them. In addition, as part of the process of creating your account, you must indicate your acceptance of the Terms of Use by selecting "I Agree" when prompted.

# If you do not understand or agree to comply with these Terms of Use, please do not use e-SPACE.

We reserve the right to make changes or modifications to the Terms of Use at any time. These changes and modifications will take effect as soon as they are posted on the e-SPACE platform or as soon as we send them to you by email, whichever comes first. You acknowledge and agree that: (i) we may notify you of such changes by posting them on the website or by emailing them to you, and (ii) your continued use of e-SPACE after such changes or modifications (the effective date will be listed at the top of this page) signifies your acceptance of the Terms of Use, as amended. It is your responsibility to review these Terms of Use for any updates.

The e-SPACE platform was designed to promote healthy aging through different training, exercises and evaluation methods. You can also allow other people (third parties), including caregivers and health care providers, to view the information stored in your profile. These third parties remain responsible for their use of the information in your profile.

## YOU ACKNOWLEDGE AND AGREE THAT E-SPACE WILL NOT BE USED TO PROVIDE MEDICAL ADVICE, CARE OR TREATMENT, OR TO SERVE AS A MEDICAL DIAGNOSTIC TOOL.

The e-SPACE platform is intended for users who are at least 18 years old. All users who are considered minors or incapacitated in their jurisdiction of residence must have the permission of, and be supervised by, their parent or legal representative when using e-SPACE.







## **REQUIRED EQUIPMENT**

Use of all e-SPACE features is dependent on your use of a tablet, computer, smartphone or similar device with adequate software and Internet access. The maintenance and security of your device can affect the performance of the e-SPACE platform. It is your responsibility to ensure that your device is operational. You are responsible for all charges related to your use of the Internet.

#### INTERNET TRANSMISSION

You agree that electronic communications and information may be accessible to unauthorized third parties whenever your device is connected to the Internet. We are not responsible for any content or data lost, altered, intercepted, or accessed without authorization during the transmission of any data or content over networks not under our control. #### INTELLECTUAL PROPERTY RIGHTS AND LICENSE AGREEMENT

Unless otherwise specified as it may be updated, developed, or improved over time, the e-SPACE platform is the property of the researchers who participated in the development of the content of e-SPACE and their institutions, including the CIUSSS du Centre-Sud-de-l'Île-de-Montréal. All e-SPACE source code, databases, functionality, software, designs, audio recordings, videos, text, photographs and graphics (collectively referred to as the "**Content**") and the trademarks, service marks and e-SPACE specific logos (the "**Marks**") are owned, controlled or licensed by us and are protected by copyright and trademark laws and various other intellectual property rights and unfair competition laws in Canada and foreign jurisdictions by international conventions.





We grant you a revocable, non-exclusive, non-transferable, limited right to use e-SPACE on electronic devices that you own or control, or that we own and provide to you for your limited use in accordance with the terms of this license contained in these Terms of Use.

By this license, you are not permitted to: (1) translate, decompile, reverse engineer, disassemble or attempt to derive the source code of part or all of the e-SPACE platform; (2) decrypt the platform; (3) make any modifications, adaptations, upgrades, improvements, translations or any derivative works of e-SPACE; (4) remove, alter or obscure any proprietary rights notices (including trademark or copyright notices) that we have registered or that have been registered by licensors associated with the e-SPACE platform; (5) use e-SPACE for any revenue-generating activity, commercial enterprise or any other purpose that we have not authorized; (6) make the e-SPACE platform available over a network or any other environment that allows simultaneous use by several devices or users; (7) use the e-SPACE platform to create a product, service or software that competes with or is intended to substitute the e-SPACE platform, directly or indirectly; (8) use the e-SPACE platform to send automated queries to a website(s) or unsolicited commercial emails.

7. Undertake any automated use of the system, including through the use of scripts sending comments or messages, or the use of data mining, robots, or similar data collection and extraction tools.

as improve and customize e-SPACE functionalities. All rights to the Analytical Code, all data recorded by this means and all work performed or usage data compiled are our exclusive property. All usage data collected will be anonymized. Your name will not appear in any reports or publications produced in connection with e-SPACE.
